

# MANCHESTER UNITED & AEROFLOT DINNER WITH A LEGEND

## COMPETITION TERMS & CONDITIONS

### 1. Definitions

- 1.1. Dinner with a legend quiz: a Quiz contest for selecting the participant and of their two friends for dinner with a MU legend. The Quiz can be accessed via website [manutd.aeroflot.com](http://manutd.aeroflot.com) available in English.
- 1.2. The dinner: The dinner with a MU Legend will take place at 8:00 p.m. (Hong Kong Time) on August 24, 2017 at the restaurant (address will be confirmed no later than 5 days before the event) in Hong Kong, China.
- 1.3. Contest Organizer: Modul-Pro (limited liability company under the laws of the Russian Federation on behalf of Public Joint-Stock Company "Aeroflot – Russian Airlines"), with the legal address located at: 195027 Saint Petersburg, Shaumyana Avenue, building 4, unit 1, office 209, TIN: 7802322397, KPP: 780601001.
- 1.4. The term Contestant is referred to as an individual who at the time of the entry is 18 (eighteen) years old, has full legal capacity, and can be bound by these Terms and Conditions. By registering in the Quiz, the Contestant accepts all provisions of these Terms and Conditions.
- 1.5. Contest period: from 10:00 a.m. on July, 28 2017 till 11:59 a.m. on August, 18 2017 (Hong Kong Time).
- 1.6. Hashtag: a link combining all materials in social networks on a specific subject. As a rule, in order to make the link active, a "#" character should be placed in front of a word or a phrase. The hashtag of the contest is #aeroflotmanutd The hashtag is used for Facebook and/or Instagram and/or Weibo accounts. For Wechat publications the link to the Aeroflot official account is needed. For Weibo, tag @Aeroflot official account is needed

### 2. Requirements for participation in the Contest

- 2.1. Participation requires registration on the Quiz website.
- 2.2. A person residing in Hong Kong and China, who is at least 18 years old at the time of entry, can become a Contestant. Residents of other countries may enter the contest but would travel to the restaurant in Hong Kong for the Dinner at his or her own expense.
- 2.3. By entering into the Contest, each Contestant confirms that his/her personal and contact information submitted with the Quiz is true and correct.
- 2.4. The Contestant must be a registered Facebook and/or Instagram and/or Weibo user in order to enter the Contest.
- 2.5. Each Contestant may only enter the Contest once.

### 3. Period and procedure of the Contest

- 3.1. Starting from 10:00 a.m. on July 28, 2017 to 11:59 a.m. on August, 18, 2017 (Hong Kong Time) everyone wishing to take part in the Contest must enter the Quiz, submit correct contact information, answer all questions of the Quiz and publish the Contest result (t-shirt and score image) with the hashtag #aeroflotmanutd in their Facebook and/or open Instagram accounts and/or Weibo and/or WeChat with mention of Aeroflot's official account.
- 3.2. The Winner of the Quiz will be determined by the number of correct answers. If there are several participants with the same highest score, the Winner will be the participant who has completed the Quiz in the shortest time.

- 3.3. The results and name of the Winner will be published on the website <http://manutd.aeroflot.com> on August 18 from 01:00 p.m. to 11:59 p.m. (Hong Kong Time).
- 3.4. The Winner will be notified about the necessity of data provision in order to get the Prize by e-mail, phone or in any other means of the Organizer's choice.
- 3.5. The Winners should contact the Organizer within 1 day after the results are announced, otherwise the Organizer can choose another Winner according to the Quiz results.
- 3.6. The Winners in 2nd to 5th place can collect their prizes from the Airport at 11:00 a.m. (Hong Kong time) on August, 24 and may also have the opportunity to meet the Legend.
- 3.7. If a Winner in 2nd to 5th place is unable to attend the airport on August, 24 to collect the prize and meet the Legend, the prize can be collected within 1 week of being notified that they have won a prize from the Aeroflot office : Hong Kong International Airport, Passenger Terminal, office 6S005, 1 Cheong Hong Road, Lantau, Hong Kong Mon-Sun: 14:00-16:00.
- 3.8. If the Winner in 1st place is unable to attend the dinner with the Legend on August, 24th, the date of the dinner will not be transferred, and the prize cannot be paid in a monetary equivalent.
- 3.9. On August, 24 the Winner in 1st place reaches airport for meeting a Legend and restaurant for Dinner by himself. The Winners in 2nd, 3rd, 4th, 5th places reach the airport for getting their prizes by themselves.

#### **4. The Prize and procedure of its presenting**

- 4.1. The Contest Winner gets the prize, which represents the right for the Winner and two of his/her friends to join the dinner.
- 4.2. The contest Winners in 2nd to 5th place will receive a T-shirt with the autograph of the MU Player.
- 4.3. All Winners (both for the dinner and for the autographed T-shirts) will be required to save the post on their Facebook and/or Instagram and/or WeChat and/or Weibo account at least 1 day after the results are announced.
- 4.4. In order to be eligible to claim the prize, the Winner must provide all necessary information upon the Organizer's request, including:
- Full name of the Winner and two of his/her friends
  - ID information for being provided with a pass to the airport duty free area
  - Photo (size - 35x45mm) for being provided with a pass to the airport duty free area not later than August 19, 2017
  - Size of the Winner's and his/her friends' T-shirt
  - Public Post on social networks (Instagram or Facebook or Weibo), which should be published until August 24.
  - Current mobile phone number
- 4.5. The Organizer reserves the right to call the Winner to discuss all the details. The Winner must reply to email and/or phone call and/or message from the Organizer for getting any additional information (4.4)
- 4.6. The 1st place Winner and two friends (participants of the dinner) have to take a photo with the Legend and Aeroflot stewardesses and post it in social networks with #manutd, #aeroflotmanutd hashtags. The 2nd-5th place Winners have to take a photo with their prize and post it with same hashtags as well.
- 4.7. User Instagram and Facebook accounts and publications must be public for the period of determining the Winners.
- 4.8. If the Participant doesn't respond to the Organizer's request following a reasonable period or refuses to provide the necessary information, the Organizer reserves the right to select a new Winner in accordance with paragraph 3.2.

## **5. Restrictions**

5.1. The Organizer has the right to dismiss any Contestant from participation in the Contest in case of non-compliance with the Contest terms and in case of other sound reasons.

5.2. The Organizer reserves the right to disqualify any Winners in case of violation of the Terms.

## **6. Personal information**

6.1. The Contestant is recognized as the Winner only after the announcement of the results by the Organizer and provision of ID documents by the Contestant to the Organizer.

6.2. We implement policies, terms and take technical safety measures for protection of personal information, being under our control, in full accordance with the legislation and guarantee confidentiality and data protection, which relates to the jurisdiction of the country where the Contest is held. In addition to the principles specified in the Council of Europe Convention "On protection of natural persons during the automatic processing of personal data", personal data processing determined by the Terms is held according to the following principles:

- Legitimacy of purposes and means of personal data processing and conscientiousness;
- Correspondence of personal data processing purposes with the purposes which were defined in advance and stated during the collection of personal data, as well as with the authorities of the Contest Organizer;
- Correspondence of the amount and character of the processed personal data and
- ways of personal data processing with the purposes of personal data processing;
- Credibility of the personal data, its sufficiency for the processing purposes, impossibility of processing personal data, excessive in relation to the purposes, stated during the collection of personal data;
- Impossibility of combining data bases of personal data information systems for incompatible purposes;

according to the Public Joint-Stock Company "Aeroflot – Russian Airlines" Privacy Policy in the sphere of personal data protection.

6.3. The Contestant provides all his/her personal data in the amount required for the Contest.

6.4. Upon expiration of the Contest Period, personal data specified in paragraph 5 of the Terms will be removed according to the defined terms of personal data storage.

The terms of personal data storage are as follows: personal data of the Winner – up to the moment of withdrawal of a request for personal data processing and storage. In case of receipt of a written application about withdrawal of the Agreement to personal data processing, the Organizer must stop its processing within 3 months after receiving such an application.

6.5. In case of absence of the above-mentioned application, the term is 3 years after the Contest completion if there is no legal basis for processing.

## **7. Rights for Materials usage**

7.1. The Organizer has the right to conduct an interview with the Winner, take photographs of him/her without his/her additional agreement, and use the following materials: interview with the Winner, photograph of the Winner, contact details of the Winner in order to announce and cover the Contest in the Internet on various resources: forums, news websites, social media; in inflight magazines, in advertising materials in other media (outdoor advertising, advertising constructions inside buildings, printing and souvenir products).

## **8. Other issues**

8.1. Participation in the Contest is Free.

8.2. The monetary equivalent of the prize awarded is not provided.

8.3. The Organizer does not bear responsibility for failure to contact the Contestant if the Contestant has provided inaccurate information.

8.4. Persons who have reached the age of 18 (eighteen) years, residing within the territory of Hong Kong and China, can participate in the Contest with the exception of employees of the Organizer and any other individuals directly involved in the organization or holding of the Contest.

8.5. The Organizer reserves the right to change the Terms of the Contest at any time without prior notification of users. Any changes come into effect at the moment of publication of the revised Contest terms on the website [www.manutd.aeroflot.com](http://www.manutd.aeroflot.com)

8.6. All kinds of relationships between the Contestants and the Organizer are governed by the laws of Russian Federation.
